#### PAYMENT TERMS AND CONDITIONS

- 1. If full payment is not received within thirty (30) days of job completion, all workmanship guarantees shall become void. However, if minor work remains to be done, no more than 2% of the total contract price may be withheld by the customer pending full job completion. After thirty (30) days, a one and a half (1½%) percent interest monthly charge will accrue on any outstanding balance. Any costs or expenses incurred to collection of any unpaid balance for professional roofing services rendered shall become the responsibility of the customer.
- 2. In the event that the Customer requests any additional work not covered within the original proposal/contract, the Customer shall promptly give written notice of the same to Red Group Services Corp. The cost of such extra work must be agreed upon, in writing, and signed by both parties before such work is commenced. Pricing and payment terms for such extra work shall be as agreed upon by parties at that time.

# **CANCELLATION**

1. This proposal/contract may be cancelled by the Customer within three (3) business days following the signing herof by giving written notice of same to the Red Group Services Corp. at the address shown on the reverse side of this form. In such event, the Customer shall be entitled to a complete refund of all deposit money given to Red Group Services Corp. at the time of execution of the agreement. Furthermore, in the event the Customer cancels this agreement after Red Group Services Corp. has commenced work, the Customer shall forfeit the initial deposit money given to Red Group Services Corp. at the time of execution of the agreement, and in addition, shall pay Red Group Services Corp. such for any labor and materials provided in excess of the deposit money, which amount is to be paid within three 3 business days of such cancellation.

# **GUARANTEE**

The following limited guarantee is provided by Red Group Services Corp. in connection with this agreement for professional roofing and siding services:

- 1. Materials Red Group Services Corp. does not guarantee or otherwise warranty any materials used in connection with this proposal. The warranty for the materials used shall be the warranty, if any, by the manufacturer of the materials used by Red Group Services Corp. in completion of this project Red Group Services Corp. hereby assigns to the Customer any and all rights and claims in and to such warranty of the manufacturer.
- 2. Workmanship The workmanship provided by Red Group Services Corp. is connection with this proposal is guaranteed to be free from defects for a period of the time we agree from the date of completion of the project. This guarantee shall cover any leak in the roof or defect caused by the workmanship of Red Group Services Corp.. Any such leak or defect discovered within the said agreed period of time shall be corrected by Red Group Services Corp. within a commercially reasonable period of time after Red Group Services Corp. receives written notice of such

defect from negligence of the Customer of their agents, servants, or employees, damage caused by storms or weather conditions, damage caused by fire, and/or damage caused by any other act of God. Further, this warranty shall not extend to damage and/or defects that are the result of characteristic common to the materials used Red Group Services Corp. shall NOT be liable for any consequential of incidental damages resulting from any defect of workmanship of material.

3. The limited guarantee provided by Red Group Services Corp. in connection with this proposal shall become effective only upon completion of the work required to be performed by Red Group Services Corp. pursuant to this agreement, any payment IN FULL of the sum agreed to be paid by the Customer under the terms of this agreement. In the event that the Customer fails to pay, IN FULL, the sums due and owing for professional roofing and siding services rendered, the limited guarantee provided by Red Group Services Corp. under this proposal shall be deemed null, void, and of no force or legal effect.
